## **Revision Policy**

Any additional information given to us during the revision period will be chargeable. Should the number of pages exceed, appropriate charges would then be applicable. In order to receive free revision, customers are required to provide request for a revision within 7 days of the completion date for essays and 14 days for dissertations unless an extension was paid for at the time of the order.

Once the above-mentioned timeline has passed it shall be assumed that the customer is satisfied. Any revision request sent by customer for plagiarism must be accompanied by a detailed report for the plagiarism found. At the time of sending the client the order, a plagiarism scan will be sent. If the work is returned as plagiarised, an investigation will be made as to when and where the work was submitted to rule our writer misconduct.

## Revision turnaround time as per urgency is as follows:

- » For orders up to 24 hours of urgency; Revision turnaround time would be 24 hours, however we do not guarantee any revisions before a 48 hour period. Therefore the absolute minimum any revision can be made within is 24 hours. Same day revisions are not possible and do not include Sundays.
- » For orders between 24-48 hours of urgency, revision turnaround time would be 48 hours.
- » In cases where large revisions are required, we ask for up to 7 days. Revisions should never take longer than 7 days in any case, large or small. If there is to be issues with a 7 day amendment period, the client will be informed at the earliest opportunity.

#### **Amendment Policy**



We provide an amendments guarantee. Through this guarantee customers can ask us for amendments in the paper description and we will entertain the amendment request. However, the topic of the paper cannot be changed. Any additional information given to us during the revision period will be chargeable

The option of increasing the number of pages of the paper is also available; however, the number of pages cannot be decreased. In the event that the numbers of pages are increased, the customer will be liable to pay the extra charges applicable for them.

In order to receive free amendments, customers are required to provide request for a revision within 7 days of the completion date for essays and 14 days for dissertations. Customers are given the option at checkout to extend the revision period, up to 3 months, for a fee.

Once the above-mentioned timeline has passed it shall be assumed that the customer is satisfied.

All amendment requests pertaining to customers order will be completed as per the urgency of the order with 24 hours as standard minimum turnaround time, yet without guarantee before 48hours, not including Sundays.
